## **TRADING INFORMATION**

### **TRADING CATEGORIES 2018**

**Category A - Hot / Cold Food and Meals (including, but not limited to - burgers, pizzas, BBQs, sandwiches, baguettes and crepes).**

- Frontage up to 4 metres: £350
- 4-5 metres: £400
- 5-6 metres: £450
- Over 6 metres: please ask

**Category B - No hot food (including, but not limited to - coffee, hot/cold drinks, smoothies, juices, sweets and cakes).**

- Frontage up to 5 metres: £200
- Over 5 metres: please ask

**Category C - Retail (including, but not limited to arts & crafts, clothing and any other non-food items. Massage, healing, charities and other services).**

- Frontage up to 3 metres: £50
- 3-4 metres: £80
- 4-5 metres: £110
- 5-6 metres: £140
- Over 6 metres: please ask

**Category D – Bar (serving alcohol).**

- There are **no** remaining pitches available for bars or alcohol sales

## **CANCELLATION**

Important - Please note that if the festival is cancelled due to poor weather, health and safety issues or any other circumstance outside of the organiser's control, you will be entitled to a 50% refund of your traders' fee. If a separate event is organised in lieu of the festival, traders will be offered a space free of charge on a first come first serve basis.

## **PAYMENT**

Following the deadline of **1st May 2018**, we will contact you to confirm whether or not you have been successful in your application. If you have been successful, you will be required to pay 100% of the pitch fee no later than **6th May 2018**. If you fail to pay by this date, you will be unable to trade, and will not be entitled to a refund of your deposit.

## **RIGHT TO REFUSE**

Due to the high volume of applications and limited space, **the completion of an application form does not constitute acceptance to trade**. We will contact you to inform you if your application has been successful or not via email following the deadline of **1st May 2018**.

## **PITCH SIZE**

It is imperative that you submit the accurate size of your stall (pitch size must include tow hitch and guy ropes where applicable) on your application or we cannot accept your form.

If the size of your stall is larger than you stated in your application, you may not be able to trade at the festival and you will not be refunded your traders fee.

All pitches are measured and marked prior to your arrival.

## **INSURANCE & RISK ASSESSMENT**

All traders must hold their own public liability insurance, product liability insurance and employer's' liability insurance where appropriate.

All traders are also required to have carried out a full risk assessment of the potential hazards associated with their particular activity.

Copies of these documents must be submitted with your application form.

## **PRICING OF GOODS AND SERVICES**

We request that all vendors, especially those selling food, keep prices reasonable. Positive Vibration is an event that is attended by many people from a variety of backgrounds.

## **ALCOHOL**

The selling of alcohol by traders is not permitted, **unless it has been approved by Positive Vibration beforehand**. Any traders found to be selling alcohol will be removed from the festival site and will not receive a refund of their fees.

## **TRADING CATEGORIES**

Traders must only sell goods and services that are in the category to which they applied. Traders who are found to be in violation of this policy will be either required to pay an additional fee or may be required to cease trading and leave the site, depending on circumstances.

## **SET-UP AND SUPPLIES**

All traders at Positive Vibration will be required to provide their own self-contained unit, tent, marquee, gazebo or stall cover and **ensure it is a sturdy structure and will stand up to adverse weather conditions**. Please be aware that the festival will take place on hard ground/concrete, so please ensure that any structure is suitably weighed down.

Traders must also provide any equipment, tables, chairs and lighting they may need. Please note that there will be access to water on-site, but traders will need to bring their own water containers.

Please supply any photos, drawings, plans or other information to support your application.

## **ARRIVAL**

The festival management team will be on site early on **Friday 8<sup>th</sup> June 2018**, and will direct you to your allocated space upon arrival. Many factors are considered in the positioning of your stall and your allocated pitch is final. Set up times are between 9.00am and 1pm on **Friday 8<sup>th</sup> June 2018** (subject to change). ALL traders must be ready to trade from 5pm and no vehicles are permitted to move on or off site after 4pm.

A reminder email with details will be sent to all traders nearer to the festival, but please keep a copy of the application form and terms and conditions for your reference.

## **MISCONDUCT**

Any trader who is rude, abusive or who conducts themselves in an inappropriate manner to any member of the Positive Vibration team will be asked to leave the site immediately and no refund will be given.

## **SECURITY**

Overnight security will be provided at the festival site.

Positive Vibration will not be liable for any loss or damage to any trader's property, products or possessions.

## **ELECTRICITY**

Electricity must be ordered on your application form. The cost of the power you require should be factored into your 50% deposit.

## **FIRE & SAFETY**

All electrical equipment must be in good condition and correct storage procedures adhered to.

You will need to supply your own fire extinguishers and fire blankets.

Traders must have current PAT certificates on hand at the festival ready for inspection by a Health & Safety Officer.

Gas powered appliances and correct storage procedures must be adhered to and all relevant documentation and fire extinguishers must be available for inspection on site by the Health and safety officer.

## **WASTE DISPOSAL**

Traders are expected to keep their surrounding area clean throughout the duration of the festival and have black bin bags on their stall. Bins will be provided across the site and will be easily accessible to traders.

## **ENVIRONMENTAL HEALTH & TRADING STANDARDS**

Traders are expected to fully comply with current Health & Safety and Environmental Health legislation and adhere to Liverpool City Council's Trading Standards. Stalls will be inspected during the weekend by EHO and any that fail to comply with relevant legislation may be shut down and will not be given a refund of fees.

Traders are required to co-operate with site managers, security, emergency services and organisers of the festival.

## **AUTHORISED VEHICLES**

There must be no movement of vehicles on-site once the festival has opened. If you need a refrigerated vehicle on-site you must notify us well in advance of the festival to determine any power/siting requirements and an appropriate charge will be levied.

**For the avoidance of doubt, please note there is no parking of vehicles on the festival site. Please contact the organiser for information on nearby car parks.**

## **SUB-LETTING**

There will be no sub-letting of stalls under any circumstances. If a trader who has not gone through the official application process is found to be selling goods or services at the festival, they will be removed immediately. No refunds of the trader's fees will be offered.

## **WITHDRAWAL FROM FESTIVAL**

If you wish to withdraw from trading at Positive Vibration after a successful application and have paid your deposit, you will be refunded half of the deposit if notice is given prior to **6th May 2018**. If you provide notice after **6th May 2018**, you will not be entitled to a refund.

Please note that this policy applies regardless of the reason for withdrawal.

## **SITE DEPARTURE**

At the end of the festival you must ensure your pitch is left exactly as it was when you arrived – clean and free of any waste.

Food waste is not to be emptied onto the floor. This must be taken away with you and any rubbish put into the bins provided or taken away.

If you are happy with the information given and you agree to commit to trade for the whole weekend, then please complete the application form **on the next page**.

**No generators will be permitted on site.**

If you fail to pay the remaining amount by this date, you will be unable to trade, and will not be entitled to a refund of your deposit.
